Road Department

CRS Contracting has postponed closing Penn Drive from Route 8 to the entrance of the Shadow Ridge Development to install the new water service main line. This work will be rescheduled at a future date.

Recycling Report

Mrs. Zerfoss reported on the Penn Township 2024 recycling event on September 7, 2024. Last year, 179 Penn Township residents brought in 21,012 pounds (10.5 tons) of electronics and Household Hazardous Waste (HHW). This year, 202 vehicles were registered. Mrs. Zerfoss said she would report the tonnage when she receives the report.

Parks and Recreation Department - Harcrest Park Phase II

The Butler County Conservation District (BCCD) issued the Harcrest Park Phase II NPDES permit on July 24, 2024.

HRG provided the application for Penn Township to renew the Butler County Conservation District (BCCD) NPDES permit. Penn Township signed the application and forwarded it to the BCCD along with the fee.

The next Park Committee meeting will be scheduled for later in the Municipal Building meeting room.
